Terms and Conditions:

Eligibility:

The competition is open to all persons, except professional photographers.

Entry Requirements:

- Entrants are limited to a maximum of three(3) photographs;
- Each photograph must be accompanied by an entry form;
- Photographs can be taken with a film or digital camera, but must not be modified;
- Entries must be received by 5pm on March 3rd 2010;
- Entrants warrant that photographs entered are their own original work;
- Photographs must be taken after the date of June 1st 2009;
- Photographs submitted must be a minimum of 10cm x 15cm and a maximum of 21cm x 29.5cm (A4 size);
- Ideally the photograph would be mounted on a piece of firm white cardboard no large than 21cm x 29.5 cm (A4 size);
- The Applefest committee accepts no responsibility for lost/late entries.

Submission of Entries:

Entrants may enter the competition by:

- Delivering the entry form(s) and photograph(s) in a sealed envelope to the Harcourt General Store
- Posting the entry form(s) and photograph(s) to Applefest Photographic Competition, PO Box 56, Harcourt VIC 3453.

Late entries will not be considered.

All care will be taken with the photographic entries, but no responsibility will be taken by the Applefest committee for any lost, stolen or damaged entries.

Judging:

The winning entries will be decided by the judges. The judges' decision is final and no correspondence will be entered into.

Categories:

Landscape—an expanse of natural scenery (may incorporate man made structures such as buildings, dams and fencing).

Portrait—a representation of a person to give personality (may incorporate any background appropriate, however the person is the focus)

Icon—any object as central to the image, including but not limited to animals, buildings, furniture, artwork, structures and food.

Harcourt—this category will be awarded from all categories for the photograph that best portrays the life/community of Harcourt.

Use of Photographs:

Entrants grant the Applefest committee perpetual, royalty free licence over the photographic images to reproduce, copy, supply, modify and/or publish the photographs for the purposes of:

- Promoting the Applefest and/or Harcourt community;

Privacy:

Information collected on this entry form is used for the purposes of:

- conducting the competition, exhibition and awarding prizes;
- promoting this and future photographic competitions;
- promoting the Applefest and/or Harcourt community.

The Applefest committee will disclose the entrant's name and age to the public if selected as a winning entry in any category.

Consents:

Entrants warrant that they have gained the consent of the persons whose images who appear in the photograph(s) (or in the case of a minor, or person without legal capacity, and consent of a parent or legal guardian), to the photograph(s) being collected, held and used by the Applefest committee, and that they are aware that their photograph will be:

- submitted into the competition;
- used for purposes in relation to the competition;
- published, displayed or otherwise disclosed to the public;
- stored in the Applefests' image bank;
- used and/or reproduced in publications for the promotion of Applefest and/or the Harcourt Community.

Entrants warrant that they have received all permissions necessary to take photographs submitted, including but not limited to permission required to take photographs in/on non-public premises any painting, sculpture, drawing, engraving or other artistic work visible in the photograph submitted.

Entrants indemnify the Applefest Committee against any claims and/or costs arising from the entrants failure to obtain subject's consent and/or permission to take photographs submitted to the competition.
